2. Up to a maximum of four people in a team per entry.
3. Entry is free and a Solo account is not required.
4. Entry forms need to be completed in full and signed by a parent/guardian and submitted as follows: via email to marketing@bankwindhoek.com.na; posted to Bank Windhoek Marketing and Corporate Communication Services, Bank Windhoek BizzKids Competition, P.O. Box 15, Windhoek; delivered to any Bank Windhoek branch or hand delivered to the 1st floor, the Forum Building, Dr. Frans Indongo street.
5. The **deadline** for submission of all entries is **31 August 2017 at 16:30**. No late entries will be accepted.
6. The judges' decision for the selection of the finalists are final and no correspondence will be entered into in each category.
7. The finalists will be informed telephonically and confirmed in writing by 23 September 2017.
8. The finalists will receive the following prizes: a space to sell their goods and services at the Bank Windhoek BizzKids Market which will be held at Maerua Mall of Namibia on 27 and 28 October 2017; a free t-shirt, backpack and cap and a table and two chairs for their stand.
9. Prizes will be offered in the following categories: The finalist entrepreneurs will each receive a certificate of recognition. The top 3 in each category will receive a cash prize as follows: 1st – N\$7 000; 2nd – N\$5 000; 3rd – N\$3 000.
10. The top 3 winners in each category will be announced on 28 October 2017 at 15:00, at the Bank Windhoek BizzKids Market, in Windhoek.
11. The judging criteria for the top 3 will include: execution of business plan; originality of goods/services; set up and attractiveness of the stall; sales techniques applied, passion and enthusiasm of entrepreneur/team and the overall impression of the stall.
12. The school of the winning entrepreneur/team will receive N\$5 000 in cash.
13. The finalists are responsible for their own travel and accommodation costs to travel to and participate in the Bank Windhoek BizzKids Market in Windhoek.
14. The finalists are responsible for the branding/signage of their stall without damaging any of Bank Windhoek's promotional material. The items provided (table, chairs) remain the property of Bank Windhoek.
15. The finalists may not take up more space than the space provided to you.
16. Bank Windhoek will not be held liable for any damage or loss of the finalists property or goods.
17. Parents/guardians can help set up the stalls, but are not allowed to help with the selling of goods and services. Bank Windhoek reserve the right to disqualify a person/team if a parent/guardian is involved in the selling of goods and services.
18. Entrepreneurs may not sell typical adult products.
19. The following stalls are not allowed and will not qualify: sale of live animals, sale of cool drink and ice cream. No food may be cooked or prepared at the stall.
