- With the exception of specialists non-governmental organisations, trusts, foundations and consultants that will provide a service to the community on behalf of subsidiaries, funding should be directed to the organisation and not through intermediaries or third parties
- In special circumstances, agreements may be entered into with a reputable international aid - or development agencies
- Projects are funded up to a maximum of three years
- The maximum amount for funding per annum is **N\$250,000.00**
- No funding will be provided for projects outside the borders of Namibia
- No funding will be covered for infrastructure development, capital equipment and buying of vehicles
- No funding will be covered for international travel initiatives/events
